If you do not agree with the terms and provisions of this agreement, you are in the case of the delivery of the title application on CD-ROM to return the unopened container together with the remaining materials to me or to the distributor from whom you acquired it. This package includes software and associated explanatory material. The terms software and application titles also include all upgrades, all modified versions, updates, additions, and copies of the software you licenced by Karsten Worm.

I, Karsten Worm, InfoSoftWare, grant you a nonexclusive licence to use the software and accompanying materials insofar you agree to the following conditions.

1. Use of the Software

With the acquisition (purchase) of the title applications and the software: ViewLit - Professional related standard licences:

a.) Private single-user licence (Private Einzelplatzlizenz (Nur für Privatkunden)):

a.) You may install the Software on a single computer, without passing neither the CD-ROM, nor the software or the texts, fonts, or any distributive material of the database down to a third party (see also below passage 2 and 3). A personal second installation - for example on a laptop beside to a desktop installation - is approved, as far as the use of the program and each title application is limited on the sole owner (or purchaser), and simultaneous access by third parties is excluded.

b.) Institutional licence (Multi user in locally limited standalone installation in a public library or reading room within the rooms of a specialized institute) (Institutionelle Lizenz (Mehrfachnutzungsmöglichkeit, bei lokal begrenzter Einzelplatzinstallation im Lesesaal einer öffentlichen Bibliothek oder innerhalb der Räumlichkeit eines Fachinstituts)):

c.) Campus network licence (Campusnetzlizenz):
